**Conference Matrix Update**

Elaine reports no sessions withdrawn, and very few individuals withdrawn. The few session conflicts people identified have been resolved. Session abstracts have been requested **January 13<sup>th</sup> is the deadline**.

**Requests for Room Space**

There have been a number of requests for meeting space outside of the symposium. One request from the EPA Tribal Pesticide Counsel specifies time during the Thursday morning plenary session. The committee felt it would be a great loss to the Tribal Pesticide Council members if we granted meeting space during the closing plenary sessions. We hope to encourage the members to join the closing symposium sessions, we do not want to lose their participation. Conclusions drawn and action items determined during the last symposium yielded significant recovery of IPM funding to name just one major outcome. The program committee therefore respectfully requests the participation of the EPA Tribal Pesticide Counsel members to attend the final plenary speaker sessions and wrap-up discussion. The symposium program finishes at 12:45pm Thursday.

**Plenary Speaker Updates**

Sherry is also working with Jim Jones (Assistant Administrator of EPA's Office of Chemical Safety and Pollution Prevention), who may serve as a co-presenter or alternative presenter to Larry if need be.
