

Commercial PMP

- ★ Pest inspection
- ★ Pest IDentification
- ★ Document deficiencies
- ★ Client recommendations
- ★ IPM strategies
- ★ Monitor progress

Commercial Food Client

- ★ Structural integrity/maintenance
- ★ Exclusion – openings
- ★ Exclusion – incoming shipments
- ★ Cleaning and Sanitation
- ★ Trash handling
- ★ Lighting – type and management
- ★ Drainage and drains
- ★ Landscaping and environment
- ★ Pest sightings/reporting
- ★ Employee behavior/cooperation





Summary

Successful IPM programs and (food safety) require the cooperation of the food company client and all of their employees. Without it, the pest control program will regress to regular pesticide applications. Partnerships and teamwork are critical to the success of IPM programs, not just in the food industry.
