Before highlighting specific OSHA safety standards, we want to briefly review OSHA itself. Founded in 1971 by the Occupational Safety and Health Act (the Act), OSHA is charged with protecting our nation's workers, and strives to accomplish its goal through enforcement, education, and outreach.

OSHA's On-site Consultation Program

This program offers free and confidential advice to small and medium-sized businesses in all states across the country, with priority given to high-hazard worksites.

On-site consultation services are separate from enforcement and do not result in penalties or citations. Consultants from state agencies or universities work with employers to identify workplace hazards, provide advice on compliance with OSHA standards, and assist in establishing injury and illness prevention programs.

State OSHA Plans

States are encouraged to develop and operate their own job safety and health programs. If a state does not choose to establish a state OSHA plan, the Federal statutes apply.

Currently 22 states/ jurisdictions operate state plans that cover both private sector and state/local government employees. Five states have plans that cover public employees only.

The states highlighted in blue below have state OSHA implementation plans. These plans may be more restrictive than the Federal statutes; but they must at least meet the Federal rules.

Program Integrity

- At each renewal, certified companies send a signed affidavit along with their payment.
- Every year, 10% of certified companies are randomly selected for an audit. Selected companies are asked to supply evidence that demonstrates compliance with the QualityPro Standards.
- A grievance procedure is in place ([detailed in the Bylaws](#)). When a complaint is received, both the reporting company and the reported company receive audits. The reporting company remains anonymous.
